## Biographical Sketch

Theressa Cornella Gilliam was born in 1911 in Oklahoma City, Oklahoma. She was a graduate of Lincoln High School in Kansas City, Missouri, and worked as a licensed nurse in Illinois, Kansas, and Missouri. Gilliam later served on the Patient Advisory Committee at Truman Medical Center. Her husband, Samuel Gilliam, was born in 1901 in Gilliam, Missouri. The couple had one child, Constance. Samuel Gilliam died in 1962. Constance Gilliam McCrorey died in 1999. Theressa Gilliam died in 2006.

## Scope and Content Note

This collection primarily consists of correspondence received by Theressa Gilliam from family, relatives, and friends. The correspondence mainly addresses family affairs. Many of the letters have their corresponding envelopes; photocopies of envelopes were also found in the collection.

The collection contains some World War II related items, including an incomplete application for employment at the Sunflower Army Ammunition Plant and ration books. The collection also includes other documents concerning financial matters and Constance

Gilliam's schooling, photographs and negatives, and small artifacts. Photographic negatives have been withdrawn to Box 4.
