## Biographical Sketch

Dr. Carl M. Peterson was born June 5, 1914, in Opelika, Alabama, to Lewis and Carrie Bell Peterson. He attended high school at Tuskegee Institute, graduated from Morehouse College in 1937, and earned his Doctor of Medicine degree from Meharry Medical College in 1941. Dr. Peterson served in the Army Medical Corps in the South Pacific during World War II.

Dr. Peterson, along with Drs. William R. Peterson, John F. Ramos, and Samuel U. Rodgers, opened The Doctors Clinic at 1203 Paseo Boulevard in Kansas City, Missouri, in 1949. It was the first African American multispecialty physicians group practice west of the Mississippi River. The practice moved to a larger facility at 2701 E. 31<sup>st</sup> Street in Kansas City, Missouri, in 1961.

Dr. Peterson served as President of the medical staff at Truman Medical Center when the two city hospitals were merged. He ended his career as Chief of Surgery at Research Medical Center in Kansas City, Missouri. Dr. Peterson died December 17, 2007.

## Scope and Content Note

This collection contains materials relating to the life and career of Dr. Carl M. Peterson. Series 1-8 consist of personal papers. Series 9-10 consist of materials related to business activities of The Doctors Clinic.

## Series 1: Scrapbook, 1930-1977

Series 1 consists of a scrapbook. The series is arranged numerically by page number. A digital copy of the scrapbook is available for viewing in the reading room.

## Series 2: Correspondence, 1954-1990

Series 2 consists of correspondence concerning Wheatley-Provident Hospital's decision not to renew Dr. Peterson's staff appointment in 1954, congratulatory notes regarding Dr. Peterson's election to Chairman of the Citizens Association in 1968, and letters from friends. The series is arranged chronologically.

## Series 3: School Records, 1934-1937

Series 3 consists of school records, including Dr. Peterson's diploma from Tuskegee Institute and commencement programs from Tuskegee Institute and Morehouse College. The series is arranged chronologically.

## Series 4: Military Records and Artifacts, 1942-1951

Series 4 consists of military correspondence and memorandums, military service documents, and a commemorative booklet for the 1887 Engineer Aviation Battalion. The series also includes Peterson's dog tags, military service ribbons, and insignia pins. The series is arranged by item type. Oversize items have been withdrawn to Oversize Box 1. Artifacts have been withdrawn to Box 5.

## Series 5: Conference Papers and Publications, 1950-1978

Series 5 consists of conference papers and publications by Peterson. The series is arranged chronologically. The photographic negative has been withdrawn to Box 6.

## Series 6: Programs and Souvenir Booklet, 1965-1991

Series 6 consists of funeral programs, a souvenir booklet commemorating the centennial of Thompson Chapel A.M.E. Zion Church in Opelika, Alabama, and programs for a "Tribute to Brother Dr. Cleveland W. Eneas" and the 1991 Missouri State Medical Association Presidential Inaugural. The series is arranged by item type.

## Series 7: Clippings and Newsletters, 1949-1988

Series 7 consists of newspaper clippings concerning Dr. Peterson, The Doctors Clinic, and Opelika, Alabama. The series also includes Research Medical Center staff newsletters with articles concerning Dr. Peterson. The series is arranged by item type.

#### Series 8: Artwork, 1977

Series 8 consists of a color print of a painting of General Hospital #2 presented to Dr. Peterson by the Truman Medical Center Board of Directors. The print has been withdrawn to Oversize Box 1.

#### Series 9: The Doctors Clinic Record Book, 1949-1951

Series 9 consists of a record book for The Doctors Clinic. The volume includes articles of incorporation, by-laws, and board of directors meeting minutes.

## Series 10: The Doctors Clinic Files, 1949-1989

Series 10 consists of The Doctors Clinic business files. The files include news releases and public relations materials, photographs, and materials concerning construction of The Doctors Clinic facility at 2701 E. 31<sup>st</sup> Street, the business partnership, and other legal and financial matters.
