The court:

- Informs the defendant of verdict/finding, asks the defendant whether (s)he has anything to say why judgment should not be pronounced, and finds that no sufficient cause to the contrary has been shown or appears to the court.
- Defendant has been advised of his/her rights to file a motion for post-conviction relief pursuant to Rule 24.035/29.15 and the court has found
  - Probable cause     No probable causeto believe that defendant has received ineffective assistance of counsel.
- Finds the defendant has pled or been found guilty of a dangerous felony, as defined in section 556.061, RSMo, and if committed to the Department of Corrections, must serve at least 85% of the sentence.
- Finds the defendant has pled or been found guilty of an offense for which probation and parole are not authorized.

On count 1, the Court:

- Suspends imposition of sentence. Defendant is placed on probation for a period of \_\_\_\_\_ under the supervision of \_\_\_\_\_. Defendant shall comply with the conditions set forth in the separate Order of Probation.
- Sentences and commits the defendant to the custody of Missouri Department of Corrections for a period of 3 years. Sentence to be served

- The clerk to deliver a certified copy of the judgment and commitment to the sheriff.
- The sheriff to authorize one additional officer/guard to transport defendant to the Department of Corrections.
- That judgment is entered in favor of the state of Missouri and against the defendant for the crime victims compensation fund for the sum of

- Court Costs and Fees shall be waived except for the Crime Victims' Compensation Fund Fee.
- Defendant to report immediately to the Sheriff's Department for fingerprinting. The Defendant is ordered to submit to the fingerprinting, and is further ordered to provide all information necessary for the officer taking the fingerprints to fully complete all identification and photograph portions of the standard fingerprint cards.
- Defendant to register as a sex offender with the chief law enforcement official of the county or city not within a county in which (s)he resides within three (3) days of conviction, release from incarceration, or placement on probation.

- The court sentences §559.115.2, RSMo, General Population Department of Corrections shall provide a report and recommendation whether probation should be granted.

The court recommends placement to §559.115.3, RSMo, 120-day program:

- Institutional Treatment Program  
Department of Corrections shall provide a report and recommendation whether probation should be granted 30 days prior to the probationary release date.  
(Statutory Discharge)
- Shock Incarceration Program  
Department of Corrections shall provide a report and recommendation whether probation should be granted 30 days prior to the probationary release date.  
(Statutory Discharge)
- The court recommends placement to the Sexual Offender Assessment Unit pursuant to §559.115.6, RSMo. (Mandatory if the Defendant has pled guilty or been found guilty of sexual abuse, class B felony – See §559.115.5, RSMo.) The Department of Corrections shall provide a report and recommendation whether probation should be granted.


The court further orders: Defendant's current bond of \$30,000, 10% deposit approved, shall remain in place as previously ordered. Defendant shall be subject to the following special conditions of bond:

1. Pursuant to Supreme Court Rule 30.16, defendant shall file or cause to be filed a signed acknowledgement specifying the post office address to which all notices in connection with the case may be mailed. Defendant shall render himself in execution as ordered, and shall obey every order/judgment entered by the appellate court and every order/judgment entered by this Court at the direction of the appellate court.
  2. Defendant shall reside within the State of Missouri at all times, and shall not leave or travel outside the State of Missouri, except for daily, non-overnight required by his employment.
  3. Defendant shall immediately surrender to the Department of Criminal Records any passport held by him or certify as part of his Rule 30.16 acknowledgement that he does not have a passport issued to him. Defendant shall not apply for a passport or seek renewal of an existing passport during the pendency of any appeal.
  4. Defendant shall be prohibited from possessing a firearm, being in the presence of firearms, or residing anywhere firearms are present.
  5. Defendant shall have no contact with any family member of Cameron Lamb and any other person who was a witness in the trial of this case, or who may be a witness at any retrial.
- Defendant is placed on house arrest with electronic monitoring for a period of \_\_\_\_\_. All costs associated to the electronic monitoring shall be charged to the defendant.
