Biographical Sketch:

Marriage is an ancient human tradition. However, in the fledgling United States, slaves were not allowed to legally be married, as they were not seen as human. While they could have a "marriage", that marriage could be destroyed on a whim if their master demanded it or sold one or both spouses. However, that changed after the American Civil War. Union soldiers were ordered to formalize marriages among slaves in places they took from the Confederacy. Some of these marriage formalizations happened in Missouri, which is where the records from this collection focus on.

Scope and Content Note:

Series 1: Missouri Familial Records

This series contains records from families in Missouri during the 1800s through the 1920s. There are mostly marriage records, along with some death records and child birth records from different counties in Missouri.
