Nation of Islam Collection (AC129)

Introduction:

The Nation of Islam Collection contains materials related to the Nation of Islam, a Black Nationalist religious movement, founded by Wallace Fard Muhammad in 1930. The Nation of Islam's religious beliefs and practices draw from Christianity and Islam; however, it is considered heretical by orthodox Muslims. This collection also contains documents related to the United Nation of Islam, a splinter group headquartered in Kansas City, KS, formed in 1978.

Original Language Statement:

The Black Archives of Mid-America follows the widespread practice of using the language provided by speakers and writers of historical documents. Using the speaker's or writer's language can be highly informative and provide pivotal contextual information about cultural and societal customs of previous time periods. As a result, researchers may encounter descriptive language, which often includes verbiage that contains obvious bias, or outdated and stereotypical terminology, and/ or content. Contemporary readers and researchers might find this language harmful or offensive.

Historical Sketch:

Nation of Islam, 1930-Present-

The Nation of Islam (NOI) was founded by Wallace D. Fard Muhammad in Detroit, MI, in 1930. Even though he established the first NOI temple (or mosque) in 1931, Wallace "disappeared" (died) in 1934. Elijah Muhammad, Wallace's second in command, took over as leader of NOI after Wallace. The Nation of Islam grew in national prominence during the 1950s and 1960s. By 1955, the organization had grown from four temples to fifteen. Two of its most famous members at that time were Malcolm X and Muhammad Ali.

After Elijah's death in 1975, his son Warith Deen Mohammed, also known as W.D. Mohammed, took the reins. He was drawn towards orthodox Sunni Islam and changed the name from the Nation of Islam to World Community of al-Islam in the West, then changed the name again in 1978 to the American Muslim Mission, moving away from their more radical teachings. He retired in 1985 and dissolved the group. Warith died in 2008.

While most of the group's members continued to follow their leader and turned to follow orthodox Islam, some disagreed. John Muhammad, Elijah Muhammad's brother and Warith's uncle, and Silis Muhammad each formed their own organization in the wake of the dissolution; both were called the Nation of Islam. These groups continued to follow the teachings of Elijah Muhammad. In 1978, Louis Farrakhan, who had joined NOI in the 1950s and become leader of the New York Temple after Malcolm X's assassination, also formed his own group called the Nation of Islam, which continued to follow the teachings of Elijah Muhammad. Farrakhan was

able to reestablish his version of the Nation of Islam as a national movement. In 1979, he founded the Final Call newspaper, and in the 1990s, he expanded the organization on an international level. Yet, he, too, eventually led the group to become more orthodox in 2000, after surviving a brush with prostate cancer.

The NOI drew some of its beliefs from Christianity and many more from Islam; however, its Afrocentrism sets it apart. Members of the Nation of Islam acknowledge God as Allah and Muhammad as a Prophet; however, it also teaches that the NOI leaders are divine prophets. Like orthodox Islam, members of the NOI avoid drugs, alcohol, and pork. Additionally, NOI spiritual lore teaches that the first humans were Black and includes the story of Yakub, an evil Black scientist who created the white "race" 6,000 years ago.

The Nation of Islam has been labeled a Black nationalist hate group by the Southern Poverty Law Center, which tracks hate groups nationwide, and the Anti-Defamation League, founded in 1913 to stop the defamation of Jewish people, for being homophobic, antisemitic, and having connections to white supremist groups despite the fact that Nation of Islam's anti-white ideology.

United Nation of Islam, 1978-2021-

Royall Jenkins, a member of the Nation of Islam during Elijah Muhammad's leadership, formed the United Nation of Islam (UNOI) in Maryland in 1978 in response to the doctrinal changes instituted by Warith Mohammed. Unlike his predecessor, Elijah, Jenkins also claimed to be Allah incarnate and was often referred to as Solomon. The United Nation of Islam had temples and businesses in multiple states, including New York, New Jersey, Ohio, and North Carolina. Royall Jenkins moved to Kansas City, KS, in 1996, and the UNOI headquarters moved to KCK soon after. The organization owned and operated multiple businesses on or near Quindaro Boulevard for twenty years, including a diner, bakery, and gas station. The members of UNOI from across America sent their children to UNOI's school in KCK. During this time, the organization received multiple accusations of abuse, including human trafficking and physical abuse; however, it was only after Jenkins died in 2021 that the allegations were investigated. That investigation led to a federal indictment charging eight members of UNOI with a forced labor conspiracy, including the forced labor of minors, from 2000-2012; six of those eight were found

guilty in September 2024. Also, after Jenkins' death, the United Nation of Islam changed its name to the Value Creators and then to the Promise Keepers and has since lost its properties and businesses. Due to the multiple allegations of abuse, many people have called the UNOI a cult.

Scope and Content Note:

Several of the records show evidence of water damage, many of the pages are stained from rust, and suffered from water damage. All folders containing inactive mold have been removed to Box 7. [OS] indicates Oversized Item, located in Flat File Cabinet #1 Drawer # 3.

Series 1: Nation of Islam, 1930-Present

This series contains documents created by the Nation of Islam and its members. Where possible, this collection has been divided first by the leader of the NOI, determined by the date on the documents and other context clues, then by the subject. For those documents where it was not possible to identify the date or impossible to determine which sect produced the documents, as there is some overlap in dates, these documents were placed in Series 1.5: Undetermined.

Subseries 1.1: Wallace Fard Muhammad, 1930-1933

This series contains the transcription of a radio broadcast featuring a conversation between Albert Einstein and Wallace Fard Muhammad, the founder of the Nation of Islam, in 1933.

Subseries 1.2: Elijah Muhammad, 1933-1975

Elijah Muhammad succeeded Wallace Fard Muhammad as the leader of the Nation of Islam and grew it into a national organization. This series contains documents produced by Elijah or by the NOI during his leadership.

Subseries 1.2.1: Businesses

This subseries contains information related to the Shabazz businesses established under Elijah Muhammad's leadership. [NOTE: the Articles of Incorporation are partially restricted due to fragile nature of documents.]

Subseries 1.2.2: Mosques, n.d., 1959-1975

This subseries contains information related to NOI Mosques. No 2 in Chicago. The Nation of Islam uses Mosque and Temple interchangeably. [NOTE: documents within this subseries may contain inactive mold. These records have been removed to Box 7.]

Subseries 1.2.3: Correspondence, n.d., 1958-1975

This subseries contains correspondence from leaders of the NOI: Elijah Muhammad, W.D. Mohammed (a leader under his father and eventual successor), Abbass Rassoull, the National Secretary, and others. [NOTE: documents within this subseries may contain inactive mold. These records have been removed to Box 7.]

Subseries 1.2.4: Financial Records & Receipts, 1970-1974

This subseries contains financial records from the NOI during the leadership of Elijah Muhammad. [NOTE: several folders documents may contain inactive mold. These records have been removed to Box 7.]

Subseries 1.2.5: Newspapers, Newsletters, & Magazines, 1957-1974

This subseries contains documents related to Muhammad Speaks, including a copy of the newspaper. Elijah Muhammad produced Muhammad Speaks from 1960-1975. This subseries also contains copies of the newsletter Table Talk, transcriptions of a series of conversations Elijah Muhammad has in his home with his family and followers.

Subseries 1.2.6: Saviour's Day, 1969-1974

This subseries contains documents describing Saviour's Day, a holiday celebrating the birth of NOI's founder, Wallace Fard Muhammad.

Subseries 1.2.7: Education

This subseries contains a booklet from the University of Islam. Elijah Muhammad established the University in 1934; it was then re-established by Farrakhan in 1989. This collection also contains a summary of tasks to be performed by the Publication and Lessons Department.

Subseries 1.2.8: Writings/ Sayings/ History

This subseries contains copies of some of the writings of Elijah Muhammad. It also contains a document that describes the beliefs of the Nation of Islam and the history of the world according to the NOI faith. While this document is not dated, context clues place its creation during the leadership of Elijah.

Subseries 1.2.9: Reports and Agendas, 1934, 1974-1975

This subseries contains a numerology report for Abass Rassoull, dated June 12, 1934. The goal of the report is to provide insight into one's personality and life. Numerology is the belief that numbers hold significance and looks for connections between numbers and human lives. This series also contains a report from Rassoull's travel to South America in 1974, and a post meeting summary from 1975.

Subseries 1.3: W.D. Mohammed, 1975-2008

Son and successor of Elijah Muhammad, W.D. Mohammed swiftly modified the Nation of Islam to follow more orthodox Islamic teachings and beliefs. This series contains documents produced by W.D. Mohammed or by the NOI during his leadership.

Subseries 1.3.1: Writings, 1976-1978

This subseries features writings by W.D. Mohammed.

Subseries 1.3.2: Real Estate, 1980

This subseries contains documents related to the Muhammad Community Enterprise. No other information on the Muhammad Community Enterprise is available at this time.

Subseries 1.3.3: Court Records, 1981

This subseries contains records pertaining to the estate of Elijah Muhammad.

Subseries 1.3.4: Newspapers, n.d., 1999

This subseries contains two newspaper clippings.

Subseries 1.3.5: Correspondence, n.d., 1975-1976

This subseries contains correspondence to W.D. Mohammed.

Subseries 1.3.6: Abbass Rassoull, 1976-1977

This subseries contains an employment agreement and payroll check for Abbass Rassoull.

[NOTE: This payroll check is restricted and <u>may not</u> be reproduced. Documents within this subseries may contain inactive mold. These records have been removed to Box 7.]

Subseries 1.3.7: Financial Records & Receipts, 1976

This subseries contains a single Western Union money order receipt. [NOTE: documents within this subseries may contain inactive mold. These records have been removed to Box 7.]

Subseries 1.4: Louis Farrakhan, 1978-Present

Louis Farrakhan, a follower of Elijah, formed a separate branch of the Nation of Islam, following Elijah's original teachings, in the wake of his death. This series contains documents produced by Farrakhan or by the NOI under his leadership.

Subseries 1.4.1: Advertisement

This subseries contains a flyer advertising an orientation class for the NOI.

Subseries 1.4.2: Writings, 1999

This subseries contains a study guide written by Farrakhan in 1991.

Subseries 1.4.3: Correspondence, 1982-1991

This subseries contains correspondence to and from Louis Farrakhan. It also contains copies of letters written by John Ali, the National Secretary of the NOI in the 1960s.

Subseries 1.4.4: Newspaper, 1994

This subseries contains scans of newspaper clippings from New York that discusses a lawsuit filed by inmates in NY who wanted Farrakhan to visit them and preach.

Series 1.5: Undetermined

This series contains documents with indeterminable dates and/ or it is impossible to say which iteration of NOI produced these documents.

Subseries 1.5.1: Correspondence, n.d., 1975-1997

This subseries contains miscellaneous correspondence from the 1970s, 80s, and '90s.

Subseries 1.5.2: Doctrine

This subseries contains documents related to the beliefs, practices, and doctrines of the Nation of Islam. This subseries has been further divided by topic.

Subseries 1.5.3: Miscellaneous

This subseries contains a wide variety of documents and items including 2 floppy disks, a flyer, business cards, and a black application to the Nation of Islam, among others. [NOTE: Floppy disk is unreadable.]

Subseries 1.5.4: Members

This subseries contains documents related to four members of the Nation of Islam: Dr. Shabazz, Malcom X, Muhammad Ali and Herbert Muhammad. [NOTE: Herbert Muhammad's tax records are restricted and <u>may not</u> be reproduced.]

Subseries 1.5.5: Financial Records, n.d.

This subseries contains documents related to a loan and an account book, dates unknown.

Subseries 1.5.6: Registry, 1979

This subseries contains a check in/ check out registry from 1979. [NOTE: the registry may contain inactive mold. This record has been removed to Box 7.]

Subseries 1.5.7: Real Estate, n.d., 1977-1982

This subseries contains a variety of documents related to real estate. Although none of these documents name the NOI or a recognizable member of the NOI, they are still believed to be related to the activities of the NOI.

Subseries 1.5.8: Elijah Muhammad Foundation

This subseries contains documents related to the founding of the Elijah Muhammad Foundation in Chicago, IL in 1984. No other information about the Elijah Muhammad Foundation is available at this time.

Series 2: United Nation of Islam, 1978-2021

This series contains documents related to the beliefs and actions of the United Nation of Islam, an off shoot of the Nation of Islam formed by Royall Jenkins in 1978, following the original teachings of Elijah Muhammad. Most of the UNOI documents open or close with the phrase "As-Salaam-Alaikum."

Subseries 2.1: Charter and Beliefs

This subseries contains documents related to the founding and beliefs of the UNOI.

Subseries 2.2: Education

This subseries contains documents related to the at home schooling organized by the UNOI. While this schooling took place in multiple locations, including KCK, these documents relate to laws in Maryland, which is where Jenkins originally established the UNOI.

Subseries 2.3: Correspondence, n.d., 1992-2001

This subseries contains correspondence to and from Abbass Rassoull, former National Secretary under Elijah Muhammad. Rassoull also served as National Secretary for the United Nation of Islam.

Subseries 2.4: Miscellaneous

This subseries contains miscellaneous documents such as restaurant and event flyers and recipes.

Subseries 2.5: Contracts and Receipts, n.d., 1983-2004

This subseries contains shipping receipts and contracts between various corporations and the UNOI or members of the UNOI.

Subseries 2.6: Fruit of Islam

This subseries contains an incomplete copy of the Fruit of Islam handbook; the Fruit of Islam is the paramilitary/ security arm of the Nation of Islam and United Nation of Islam. This document mentions "Allah in Person" at the beginning, those words are always used to reference Royall Jenkins, leader of the UNOI.

Subseries 2.7: Newsletters & Newspapers

This subseries contains two different newsletters produced by the UNOI. As well as a scanned article from the NY Village Voice.

Series 3: Magazine, 1979

This series contains a copy of The Now Generation Vol. 1 No. 2 from 1979. The relation of this volume to the NOI is unknown at this time. No other information about this magazine is currently available.

Series 4: Magi Center, 1979

This series consists of lessons/ books produced by the Magi Center. The Magi Center promotes the interconnected nature of faith and science. Dorothea Ramsey produced the Rose Lessons series in 1979. Connection to NOI unknown at this time.

Series 5: Notes, n.d., 1958-1960

This series contains several handwritten notes.

Series 6: Photographs, n.d.

This series contains 45 B&W and color photographs. None of the people or buildings within are identified and the dates are unknown.

Series 7: Miscellaneous

This series contains documents and artifacts that have no discernible or unknown connection to the NOI or UNOI.

Subseries 7.1: Miscellaneous Court Records, 1982-1995

This subseries contains copies of court records for United States of America v. Gilbert L. Dowdy, 1994. Gilbert Dowdy was a former KCMO Fire Chief who ran a drug trafficking ring in the 1980s. He was arrested in 1990 and sentenced to life in prison but was released in 2021. These documents specifically relate to property on E. Armour Blvd. in midtown owned by Douglas Gleason. As well as Cook County Court records from the early 1980s. [NOTE: The Joyce Brown records contain sensitive information and may not be reproduced.]

This subseries contains financial documents related to three different financial transactions.
