#### Original Language Statement:

The Black Archives of Mid-America follows the widespread practice of using the language provided by speakers and writers of historical documents. Using the speaker's or writer's language can be very informative and provide pivotal contextual information about cultural and societal customs of previous periods. As a result, researchers may encounter descriptive language, which often includes verbiage that contains obvious bias, or outdated and stereotypical terminology, and/ or content. Contemporary readers and researchers might find this language harmful or offensive.

# Biographical Sketch:

Robert T. Tad Perry was born in Iowa City, Iowa on March 11, 1943. He is the son of Thomas Amherst Perry and Lora Margaret (Turner) Perry. Perry graduated from Fayette High School in 1961 and later earned degrees from Central Methodist University and the University of Missouri. His career in higher education spanned 40 years, concluding in 2021 when he retired as the Chair of the CMU Board of Curators in South Dakota. In June 2022, Perry was inducted into South Dakota's Hall of Fame in recognition of his extensive contributions as a professor of political science for nearly 23 years and his 15 years of service as a university administrator.

In 1965, Perry married Jane Lynn Martin, and they had 2 sons, Tod and Jay Perry. Perry and Jane divorced in 1983. In 1989, Perry remarried Carolyn Summer Cross. They continue to live in South Dakota.

#### Historical Sketch:

Black Legislators (Perry's Ph.D. dissertation) is focused on a study that Perry conducted on Black Members of the Missouri House of Representatives in 1969. At that time, the thirteen members constituted the largest group of Black legislative representatives in the United States. The study examines the role of Black legislators following a significant increase in participation, which rose more than seven-fold in 1969. It utilizes data collected from oral histories, government records, publications, and newspapers. Among those whose oral histories were collected, nine representatives were from St. Louis and four were from Kansas City. Unfortunately, the researcher, Perry, was unable to interview the thirteenth representative, Leon Jordan, before he was tragically murdered in 1970.

#### Series 1: Ph.D. Dissertation

This series includes the Ph. D dissertation of Mr. Robert T. Perry, titled "Black Legislators," which was published in 1976 by R and E Research Associates in San Francisco, CA, a publisher and distributor specializing in ethnic studies. Robert T. Perry holds the copyright. The dissertation is focused on a study that Perry conducted on Black Members of the Missouri House of Representatives in 1969. At that time, the thirteen members constituted the largest group of Black legislative representatives in the United States. The study examines the role of Black legislators following a significant increase in participation, which rose more than seven-fold in 1969.
