#### Historical Sketch

Metropolitan A.M.E. Zion Church of Kansas City, Missouri, was founded in 1912 as St. James A.M.E. Zion Church. The church was originally located at 1805 Woodland. The church building was beset by fire twice, once in 1923 and again in 1945, a fire which destroyed the church building. Metropolitan A.M.E. Zion Church moved to its 2844 Prospect Avenue in June 1948. The church was rebuilt at 2828 Prospect Avenue in 1978.

## Scope and Content Note

The Metropolitan A.M.E. Zion Church Collection primarily consists of business meeting minutes covering the period 06/08/1945-03/05/1965; church bulletins covering the period 05/1961-07/1962; church collections lists covering the period 10/1961-06/1962; trustees' financial reports for 1958; and bank statements and cancelled checks covering the period 12/1957-06/1959. The collection also includes bills; an insurance policy; a

commemorative program for the opening of the new church building in 1978; a program from a service honoring Rev. William H. Seals, Jr.; and the constitution of the Sons of Varick.
